

# LEGISLATIVE POLICY COUNCIL

## *An established structure for 2026*

The Legislative Policy Council (LPC) has established an improved structure for ARDA's most influential members who are interested in state and federal legislative efforts, to provide direction for ARDA Staff and to establish priorities for future legislative action. This Council replaced past legislative structures including state committees\* (e.g. ARDA Florida, ARDA Carolinas, LARPAC). Invoices for participation will be included with membership billing which takes place in late summer/early fall. The dues amounts are based upon current working agenda as approved by Council members and are projected to be in line with past historical spending. The 2025 dues amounts billed will be the final amount charged to members for the upcoming legislative year.

**The format for the Council is as follows:**

### FOUNDER | LEADER | ADVISOR

Legislative Policy Council has 3 tiers with a hierarchy of benefits/access.

Council Membership is ONLY available to Developers or Exchange Companies

(except for the non-voting Supporter or committee category which is defined later in this document)

### **ROLE | BENEFITS | PRIVILEGES**

**2 Seats | 2 Votes** Two representatives on the LPC which entitles the Founder member to two votes towards all legislative matters in all states and at the federal level.

**Priority Invites** A minimum of one invited company representative to attend select state and federal political events as sponsored by ARDA, ARDA-PAC and ARDA-ROC from time to time on a priority basis.  
A minimum of one invited company representative to attend a minimum of 2 select events related to State Attorney's General Conferences on a priority basis (e.g. National Association of Attorneys General, Conference of Western Attorneys General, Republican Attorneys General Association, and the Democratic Attorneys General Associations)  
Invitations to LPC only legislative briefings at the ARDA Annual Events, Government Leaders Speaker Series, as well as other meetings as designated by ARDA and ARDA-ROC from time to time.

**2 VIP Invites** Invitation(s) to attend annual VIP Live Events Retreat (Note — this does not mean the invitees are annual VIP Members — they will be considered special invited guests by virtue of their status as members of the LPC)

**LPC Event 4 Invites** A total of 4 company members invited to attend the once a year legislative planning strategy meeting.

**Dues** \$50,000

### ROLE | BENEFITS | PRIVILEGES

**1 Seat | 1 Vote**

One representative on the LPC which entitles the Leader member to one vote towards all legislative matters in all states and at the federal level.

**Priority Invites**

A minimum of one invited company representative to attend select state and federal political events as sponsored by ARDA, ARDA-PAC and ARDA-ROC from time to time after such invites are offered to Founder members.

A minimum of one invited company representative to attend a minimum of 2 select events related to State Attorney's General Conferences (e.g. National Association of Attorneys General, Conference of Western Attorneys General, Republican Attorneys General Association, and the Democratic Attorneys General Associations) after such invites are offered to Founder members.

Invitations to LPC only legislative briefings at the ARDA Annual Convention, ARDA Leadership & Policy Forum, and ARDAventure VIP Retreats as well as other meetings as designated by ARDA and ARDA-ROC from time to time.

**1 VIP Invite**

One invitation to attend annual VIP Live Events Retreat (Note: this does not mean the invitees are annual VIP Members — they will be considered special invited guests by virtue of their status as members of the LPC).

**LPC Event 2 Invites**

A total of 2 company members invited to attend the once a year legislative planning strategy meeting.

**Dues** \$15,000

### ROLE | BENEFITS | PRIVILEGES

**1 Seat | 1 Vote**

One representative on the LPC which entitles the Leader member to one vote towards all legislative matters in all states and at the federal level.

**Priority Invites**

Invitations for a minimum of one company representative to attend select state and federal political events as sponsored by ARDA, ARDA-PAC and ARDA-ROC from time to time, based on availability.

A minimum of one invited company representative to attend a minimum of 1 select event related to State Attorney's General Conferences (e.g. National Association of Attorneys General, Conference of Western Attorneys General, Republican Attorneys General Association, and the Democratic Attorneys General Associations) after such invites are offered to Founder and Leader members.

Invitations to LPC only legislative briefings at the ARDA Annual Convention, ARDA Leadership & Policy Forum, and ARDAventure VIP Retreat.
